# The Kamaishi Base is up and running



Some two months have passed since the setting up of the NSKK Let Us Walk Together! Project — Kamaishi Center for Aid to Victims (the Kamaishi Base). Two volunteer coordinators, Mr. Yuji Ebihara and one clergyperson, are in residence there.

Activities in Kamaishi started with the dispatch of Fr. Iino Masayuki on April 7. Fr. Iino took relief supplies to the various evacuation centers. He made a point of visiting such small fishing villages as Hongo, Kerobe, and Oishi, laying the basis for our present activities there. A great deal was accomplished with the full-out cooperation of the Kamaishi Shin'ai (Divine Love) Church and Preschool.

Describing current activities: As part of aid in the small fishing villages, we are cleaning photographs that washed up on the beach at Hongo, which is a little ways from the center of Kamaishi City. Next is the "cushions project," which is an element in visits to temporary housing. Concerned women at St. Paul's church in Odate together with others from the Hokkaido Diocese take in orders from the temporary housing areas and distribute handmade cushions. Since there is no insulation beneath the floor in temporary housing units, one gets cold sitting there, so the residents are very happy with our efforts. We hope to deepen our relationships with the recipients of this aid and get just that close to the heart of the refugees. We will also be giving a priority to support for "housing treated as

temporary housing." Local administrations have decided to regard some of municipal and other housing units as a form of temporary housing, and they will pay the rent for such housing for no more than two years. Unlike normal temporary housing, these housing units have not received material aid, and support from volunteer and other groups has not reached them. We want to give careful attention to these areas and provide continued support for them.

Future plans include setting up a tea parlor for the temporary housing units. This support will be given in conjunction with the Council for Public Welfare, so that, having chosen a day of the week when meetings will be held, a place can be provided in the temporary meeting hall where people can gather to talk, drink tea, and pursue their interests in handicrafts and the like. We are also considering shopping trips for those facilities that do not have good access to regular shopping.

Kamaishi Base is suffering from a lack of personnel, and so even scheduled distribution of material aid is not going forward smoothly. So, we are seeking more volunteers to work at Kamaishi. We can accommodate about ten persons in our local quarters. We ask for your favor toward this work.

## Onahama Base Report



Immediately after the earthquake, aid activities were launched by parishioners, for care-givers kindergarteners and volunteers, under the direction of Fr. Kenzo Koshiyama of St. Timothy's Church, Learning of this, clergy and Onahama. laity of the Kobe Diocese launched activities of their own, helping provide a firm foundation for the Onohama Base. The reopening of the kindergarten in Onahama at the start of April brought this phase of activities to a close, but in order to continue aiding the are, a the Kobe Diocese searched for a base for operations, and with the cooperation of the Kita Kanto Diocese chose St. Andrew's Church, Hitachi as a new center. Simultaneously, it was determined that the three dioceses of Kyoto, Osaka, and Kobe would add their capacities so that this work could continue. On April 19 a service was held in St. Andrew's, Hitachi, marking the beginning of the Kyoto, Osaka, and Kobe Diocese Hitachi Volunteer Center. Over one hundred volunteers came to the center, allowing for a wide range of activities. Starting the day with morning prayer, volunteer activities took place, with meals taken in common, and the sharing of reports on work. Activities at Hitachi came to an end at the end of June, but our base of operations was shifted to the Onahama St. Timothy Volunteer Center, and on August 23<sup>rd</sup> we had an opening service of worship.

With the cooperation of the church and kindergarten, accommodations were set up within the church grounds, and local coordinators from the Kyoto, Osaka and Kobe dioceses plus a steering committee member from the Kita Kanto Diocese and many volunteers have been working together there. At present there are three foci: 1) Izumi Gyokuro temporary service to housing; 2) cooperative activities with Timothy's church and its Onahama St. kindergarten; 3) aid activities for the NSKK churches within Fukushima Prefecture. Volunteers from Kyoto, Osaka and Kobe and the Kanto area are all actively involved.

Fukushima Prefecture in particular has to deal with the great problem of



#### radiation.

We can only do small things in response, but we want to do anything we can to deepen our ties to the people of the area, including those who have become refugees, and be serving them in such a way that each may have a real sense of God's love.

Continuing the provision of aid to home-dwellers seeking basic assistance in the area of the former (smaller) Ishinomaki City. Also, together with the Lutheran Church aid ("Tonaribito") and the NPO PARCIC, we trying to develop plans for future aid toward the fishermen of the Jusanhama rea of the former Kitagami-machi who suffered in the earthquake.

We are now starting in on getting a grasp of needs for the upcoming winter. Even though we will basically rely on local purchasing, when there are high-volume
